2021-2022 THS STUDENT PARKING INFORMATION AND CONTRACT

Parking on campus is a privilege. There will be a limited number of parking permits issued based on the number of student parking spaces available. Following that, students will be placed on a waiting list. Additional passes will be issued as space becomes available. Seniors will have the opportunity to obtain a pass first, followed by juniors. Remaining passes may be made available to sophomores. Student parking is located in front of the main entrance. All students who park at Timberline must have their vehicle registered on campus. Students parking on campus without permission are subject to school fines and other sanctions. Permits are available in the main office. To ensure that those who have a permit are able to park and to avoid costly towing fees, we have established interim steps. In order to obtain a pass, please bring the following:

- ❖ **VALID VEHICLE REGISTRATION**
- ❖ **CURRENT AUTO INSURANCE**
- ❖ **DRIVER'S LICENSE**
- ❖ **\$10.00 – CASH OR CHECK MADE OUT TO THS – Payable at the ASB Office**
- ❖ **THIS CONTRACT SIGNED BY THE STUDENT AND PARENT/GUARDIAN**

Students **MUST** display the permit in the front windshield of their vehicle. Students who do not have the permit visible in the proper location and/or are parked in an unauthorized area, or in violation of safety/traffic rules, will be subject to the following:

1st Offense: Warning **2nd Offense:** \$10 **3rd Offense:** \$35 **4th Offense:** Parking Boot & \$50 Removal Fee

Students who do **NOT** have a parking permit will be subject to the following:

1st Offense: Warning **2nd Offense:** Parking Boot & \$50 Removal Fee **3rd Offense:** Parking Boot & \$100 Removal Fee
4th Offense: Parking Boot & \$150 Removal Fee **5th Offense:** Towed at Owner's Expense

If a student drives a car that is different than the one they typically drive, they should stop by the office to add this vehicle to their parking permit form (vehicle registration form and insurance is required). Students who are doing this must be sure to come to school early enough to park in the student lot, walk to the office to get the daily permit, place the permit in their car and arrive to class on time.

Students **MUST** park in the **STUDENT PARKING LOT** only. Students are **NOT** permitted to park in the Staff parking lot, by the Portables, or in the Lakes Elementary School parking lot.

Campus security will keep records of all parking violations. An attempt will be made to notify parents when a fine has been given. Students are not to sit in cars or loiter in the parking lot during the day. **There will be a \$10 fee to replace a lost permit.**

Students are to obey all posted signs and directional marking in the parking lot and on roads adjacent to school property. Students driving vehicles on campus or adjacent to the school property before, during, or after the school day or to school-sponsored activities, in a reckless or endangering manner may be subject to either school discipline and/or police citation. In addition, reckless driving may result in loss of permit. **There will be a \$10 fee to replace a lost permit. Parking Permits WILL NOT be issued until all fees/ fines are cleared from a student's account.**

Students are to lock their vehicle when leaving it parked and unattended. Neither Timberline nor NTPS are responsible for any damage, theft, vandalism, etc. that may occur.
